

Pension Application for Patton or Pattin Jackson

On the sixth day of February 1821 personally appeared in open Court the same being a Court of Record in and for the said County of Rockland Pattin Jackson aged 74 years, since the sixth day of June last past; a resident of the Town of Clarkstown, in the said County of Rockland, who being duly affirmed according to law, doth on his affirmation declare that he served in the Revolutionary War as follows.

That he enlisted in the Company commanded by Captain Amos Hutchins, Colonel Ritseman's Regiment and also in Colo DuBois's Regiment as a Lieutenant for the term of five years.

That has been placed on the Pension Roll and that the number of his pension certificate is (7644).

And I do solemnly affirm that I was a resident Citizen of the United States on the eighteenth day of March 1818 and that I have not since that time by gift, sale, or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of an act of Congress entitled "An Act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War" passed on the eighteenth day of March 1818, and that I have not, nor has any person in trust for me any property or securities contracts or debts due to me, nor have I any income other than what is contained in the Schedule hereto annexed and by me subscribed.

And this deponent further saith that he is a Carpenter by occupation and that he is and has been for some years past, so inform and debilitated as to be unable to perform any manual labor; that his family consists of himself an aged and infirm wife and a small female child.

Schedule of the Property Real and Personal of the within named Pattin Jackson, taken in open court on the sixth day of February 1821 as follows.

Real Estate—Thirteen acres of land, situate in Clarkstown aforesaid, on which is an Incumbrance by Mortgage, to Robert Berwick for Three hundred dollars, Principal and about twenty five dollars Interest money now due.

Ten acres of Bog meadow, lying in the Count of orange of low value.

The six acres of swamp bog land theretofore owned and returned by me to the Secretary of the War department in November last, has since that period been sold by me for eight dollars. For which I have received three hundred weight of Rie [Rye] and Buckwheat meal, and four dollars in money for the support of myself & family.

The eighty dollars which I returned in November last as debts owing by me then, by the pressure of my circumstances amount now to about one hundred.
