Jacob List Dec for Pension 7<sup>th</sup> June 1832

State of Kentucky

Henry County ss. On this 30 day of december 1833 personally appeared before me David Adams a Justice of the peace in and for Henry County and one of the Judges of the County court for said County of Henry Jacob List aged 73 years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of an act of Congress passed the 7<sup>th</sup> of June 1832

This declarant states that he was residing in Orange County State of New York when he entered the service of the United and served under the following named officers he states that sometime in the summer of the year 1776 he enlisted for a period of twelve months he enlisted under one James Boyle a recruiting officer and was commanded by Capt William Blain he states that the company rendezvoused at Goshen in Orange County State of New York and under the command of Capt Blain he states that he marched to Albany where he states he remained but for a short period he was then marched to the frontiers under his said Capt Blain for the purpose of protecting the exposed part of the state of repelling the Indians and British from our borders he states that after spending some time upon the frontiers the company to which he was attached was ordered to march to Saratoga to unite with the American army that had come from Quebeck he states that there they were put under the Command of General Stark and remained with him until after the surrender of Burgoyne he states that he did assist in guarding said prisoners taken from Burgoyne as far as Goshen when his twelve months for which he had enlisted expired and was discharged he further states that some time in the month of June or July which he does not recollect he volunteered for a tour of three months under Capt Samuel Jones and Lieutenant Peter Gayle he states they marched from the drownded lands in Orange County to Lackawanna Creek in the frontiers here we were met by a tribe of Indians Commanded by a Captain Brant in the forks of the creek Lackawanna a dreadful engagement ensued in which every officer was killed except a Capt John Wood who was taken prisoner and kept by the Indians for five years and after this dreadful defeat I returned to Orange County in New York after which I was employed a great part of the war in defending the frontiers in scouting and spieing parties until the year of 1781 but how long I was actually employed in the service of the United States he does not distinctly recollect he states that he has no documentary evidence of his service and knows of no living witness by whom he can prove said service he hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any state

Ques Where and in what year your Born

ans I was born in Pennsylvania near the Delaware river in the year of 1760

Ques Have you any record of your age

ans My mother had a record of my age in her Bible I some time ago saw and read it

Ques where you living when called in to the service

ans I was living in Orange County State of New York and in the year of 1782 I moved to New Jersey where I lived till the year of 1803 I then moved to Henry County Kentucky where I have lived ever since

Ques How were you called into the service were you drafted did you volunteer or were you a substitute and if a substitute for whom

ans I first enlisted for twelve months I then volunteered for three months I then was employed in scouting and spieing on the frontiers for a considerable time

State the names of some of the regular officers who were with the troops where you served and such continental and militia regiments as you can recollect

ans General Stark General Schuyler Coln Hanes Coln \_\_\_\_\_ and Coln Turston which last was killed at Lackawanna creek

Ques Did you ever receive a discharge and by whom was it signed

ans I did receive a written discharge handed to me by Coln Hamilton which discharge I got burnt up

State the names of some of your neighbours who can testify as to your character for veracity and their belief of your service as a soldier of the revolution

ans I will name Mr. Josep Reeves and Mr Stephen Shaw
