

Pension Application for Nathaniel Tom

W.15962 (Widow: Elizabeth) Married November 1773. Nathaniel died June 11, 1807.
State of New York
County of Queens SS.

On this eighteenth day of December 1844 personally appeared before me the undersigned a Justice of the Peace for and within said County Elizabeth Shoemaker resident of Flushing in said County aged seventy nine years and made solemn affirmation in due form of laws that Nathaniel Tom who was a Captain in the Army of the Revolution as married in the year seventeen hundred and seventy three to Elizabeth Hicks at Flushing in the County and State above mentioned, by Parson [blank] Bloomer the Minister of the Episcopal Church at that time.

That her mother, that is the said Elizabeth Shoemaker's mother and herself said Elizabeth Shoemaker were invited and attended the homebringing (so called) that is the party given to the relatives & friends of the married pair (that being according to the custom here) immediately after the marriage is performed.

That she does not remember the exact month but distinctly remembers that it was in the warm weather of that year that they were married. That Larson Bloomer belonged to Jamaica and used to preach one Sabbath at Jamaica and one at Flushing above mentioned, and so on alternately.

That the Peace took place in the year 1783, that Nathaniel Tom aforesaid died of a consumption in a few months after the Peace. That she positively knows that he was married to Elizabeth Hicks above mentioned before the commencement of the Revolutionary War, and at time abovementioned and in addition a circumstance impressed it as being in that year that a sermon was preached about two weeks after their apple orchard by a Methodist Church.
